Final published article (Version of Record)

The version of article after formal publication. This version includes all the amendments added by the Publisher: peer review process, copyediting, DOI assignment, online (PDF/HTML) and print formatting, citation and other linking, deposit in abstracting and indexing services.

Personal website

Personal self-maintained websites or pages created by the Authors to present their CV and research, which can be hosted on their institute's website.

Under these terms the author may make a postprint manuscript available on:
